- 1 There is only place for **50** cars. The allocation will be on a first pay first served basis from the day of receipt of the full entry fee, subject to acceptance by the organising team.
- 2. I accept that this event is potentially dangerous and uses roads that involve challenges.
- 3. I understand that the entry to this event is by invitation only and that the organisers reserve the right to withdraw or retract my invitation at any time and refund the entree fee paid.
 I understand that should the event be cancelled through act of god, war, freak weather conditions, closure of borders or any other reason beyond the control of the organiser, the entry fee will be refunded less a 15% administration charge.
 - In case of retirement by the entrant, the repayments schedule as posted in the regulations is in place.
- The organisers reserves the right to cancel the event, in which case a full refund shall be given, minus € 950,- administration cost.
- The event will be held and organised under the Event code of the FIA and the Supplementary Regulations as published. I agree to be bound by the Official Regulations and any supplementary regulations issued for this event.
- 6. Should the cost of hotel accomodation change from the quotes received on September 31 2024, we will pass these on to the competitors.
- 7. We, the undersigned agree to indemnify and hold harmless the organisers and officials of the event and all other bodies or companies and individuals associated with or participating in the event (and their respective employees and agents) against all proceedings, damages, liabilities, costs and expenses arising out of any act, default, negligence or breach of statutory duty on our part. We declare that the vehicle entered will be covered by a valid insurance for third party liability by law while driven by any member of its crew during any part of the event held on the public roads.
